

AIDS...How the statistics have been used to lie to us

"The Federal government has consistently misled Canadians about the risk of getting AIDS and continues to do so, say a University of Western Ontario professor and a Toronto epidemiologist." So begins a lengthy two-part article in *The Hamilton Spectator* (24-26 August/91) in which the newspaper has stated that we all (the media, advocacy groups, and the government) are guilty of perpetuating this lie. The article is summarised as follows.

The Federal Centre for AIDS has admitted it has no conclusive data proving that AIDS in Canada has spread sexually from women to men. This would be the only route which allows AIDS to spread throughout the general population. Toronto epidemiologist Eric Mintz says that although public education campaigns would have us believe we all have an equal chance of contracting AIDS, the actual chance of contracting AIDS for most adults is no more than dying in a commercial airline crash (about three in one million). When one looks at gay males in Canada, they are 200 to 300 times more likely to contract AIDS than heterosexuals.

Often cited studies suggest that in third world or developing countries heterosexual transmission is closely linked to widespread sexually transmitted diseases, genital ulcers, and poor health care. None of these situations, however, are significant problems in most of North America. Third world and developing countries are moreover populated by a substantial number of uneducated people, a situation which makes it difficult to talk to them about a virus when they have no technical knowledge of it.

In many Canadian poster campaigns,

there has been a tendency to "homogenize the risk of sex acts and the risk of AIDS." Unprotected anal intercourse is still very common amongst gay males. It is also practised by up to 20 percent of heterosexual couples. This activity results in a far greater risk of torn tissue and consequently of HIV getting into the blood stream, especially for the receptive partner, than with unprotected vaginal intercourse. The homosexual male therefore who engages in uprotected anal sex is consequently at greater risk for contracting AIDS than his heterosexual counterpart will by having unprotected vaginal intercourse. Unfortunately, government advertising has essentially equated the risks involved for both activities.

The gay population was the first group to contract AIDS when it first appeared in

North America. When it began to spread amongst heterosexuals it was mostly amongst haemophiliacs, prostitutes, and IV drug users who shared needles. That this population included women and non-gays set the stage for gay activists to demand that AIDS no longer be strictly linked to gays. What followed in Canada over time was a sanitized government campaign that identified everyone of being equally at risk. The stats however are very clear. Some 80 percent of all individuals dying as a result of AIDS in Canada, over the last decade, have been gay males. When looking at the number of new cases of Ontario women who are HIV positive, their numbers have plateaued since 1987 at just under 100 cases per year.

Sadly, as a result of the homogenized risk group campaign in Canada, many young gay males are unaware of their potential risk. Conversely in many European countries, where the governments are more socially progressive, funding is targeted at the high-risk groups. While some people have been loathe to identify specific high risk groups for AIDS, the stats have shown that they do in fact exist. "We are not saying AIDS is no risk to most Canadians. just that people should know the true scope of it. We are not saying people should stop using condoms; they protect against disease and unwanted pregnancy as well as AIDS. We are also not saying people with AIDS are unimportant. We

feel strongly that funding should be aimed at those in need, and the afflicted be cared for. The AIDS risk is not shared equally, but our compassion must be." In this month's newsletter, several of the GGLE Executive have included a brief article outlining each of their portfolios. We have done this to inform the membership of our roles as well as to acquaint new members with ourselves. I hope you find this useful and informative.

Education Director: Alan

Salutations to one and all. I'm the Education Director for the GGLE (You can call me Al). If you've ever called the Gayline [(519) 836-4550], you've probably wondered who the people are at the other end of the line who answer many questions on a variety of topics. Questions such as,

"Are there any Gay bars in Guelph?" to more complicated ones like, "How do I tell my wife I'm gay?" It's also part of my job to coordinate these dedicated volunteers and to ensure the line is being run properly. The line averages about four calls per night while our taped message receives over 1000 calls per year. The line is staffed Monday to Thursday from 7:30 until 9:30 pm.

Earlier this year, the Buddy System was introduced and already it has helped several people. The Buddy System is designed to help people who are just coming to terms with their sexuality. The person requesting the "Buddy" is paired with someone, who is already comfortable with their own sexuality, until they feel more comfortable with being lesbian or gay. The "Buddy" is there to answer questions about being gay or lesbian and to make "Coming Out" a non-threatening positive and productive experience. Confidentiality and honesty are the key to the system. The pace at which a "Buddy" helps their "buddy" is decided upon jointly and is supervised by myself to ensure that the system is conducted in an atmosphere of mutual respect. If you think you require a "Buddy" or would like to be one, please call the Gayline and leave your name and number.


