4. The objects for which the corporation is incorporated are:  
*Objets pour lesquels la personne morale est constituée:*

To provide a physical space for SPECTRUM, its partners and the LGBTQ / Rainbow community;

To provide a friendly and welcoming gathering space for the LGBTQ / Rainbow community that is inclusive of all people;

To provide a central location for information, referrals and support to the LGBTQ / Rainbow community – a resource centre;

To improve recognition, growth and stature of the LGBTQ / Rainbow community;

To foster partnerships and region-wide collaborations;

To provide educational material that will promote a better understanding of the LGBTQ / Rainbow community;

To connect people, ideas and resources;

To make available a DVD collection for the LGBTQ community;

To establish programmes for youth, social, educational and awareness;

To achieve regional level improvements and recognition for the LGBTQ / Rainbow community

5. The special provisions are:  
*Dispositions particulières:*

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in promoting its objects.

- i) to acquire, accept, solicit or receive by purchase, lease, contract, donation, legacy, gift, grant, bequest or otherwise any real or personal property solely for the above objects;
- ii) to enter in to and carry out arrangements, contracts and undertakings incidental thereto; including to raise and secure loans, line of credit and other financial facilities;
- iii) to hold, manage, sell or convert any of the real or personal property from time to time owned by the corporation, and to invest and re-invest any principal in such manner as may from time to time be determined;
- iv) to acquire by purchase, lease, devise, gift or other title and to hold any real property necessary for the carrying on of its undertaking for the purpose of drawing a revenue therefrom and to sell, lease, mortgage and dispose of and convey the same or any part thereof as may be considered advisable, provided that the said property shall be used solely for the above objects, and no part of the income derived from such real property shall be payable to or otherwise available for the personal benefit of any member of the said corporation.
- v) to demand, receive, sue for and recover and compel the payment of all sums of money that may become due and payable to the corporation, to apply the said sums for the objects and purposes of the corporation and generally to sue and be sued;
- vi) to employ and pay such assistants, clerks, agents, representatives or employees; and to procure, equip and maintain such offices and other facilities, and to incur such reasonable expenses as may be necessary to achieve these purposes;
- vii) to do all such other things as are incidental or conducive to the attainment of its objects;
- viii) to do all other such things as a corporation is empowered to do by the Corporations Act (Ontario) as long as these powers are not inconsistent with the objects of the corporation;


